THE GUARANTY PLACES ALL OF THE MARITAL AND PERSONAL ASSETS OF THE OWNERS, SHAREHOLDERS, PARTNERS AND MEMBERS AND THEIR SPOUSES, INCLUDING YOUR HOUSE, AT RISK OF BEING LOST IF THE FRANCHISE BUSINESS FAILS.

THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you.
