You will operate a store-front business offering the retail sale of recycled, refilled ink and toner cartridges at substantially lower prices than that of new cartridges and which conduct ink and toner cartridge recycling and refilling services on the premises.

The initial franchise fee is \$29,000. The estimated initial investment ranges from \$118,433 to \$182,700.

**RISK FACTORS:** 

1. THE FRANCHISE AGREEMENT REQUIRES THAT CERTAIN DISAGREEMENTS BE ARBITRATED (OR LITIGATED, IN CERTAIN INSTANCES) IN MECKLENBURG COUNTY, NORTH CAROLINA. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN NORTH CAROLINA THAN IN YOUR HOME STATE.

2. THE FRANCHISE AGREEMENT STATES THAT NORTH CAROLINA LAW GOVERNS THE AGREEMENT; HOWEVER, NORTH CAROLINA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW.
