The franchise offered is for the establishment and operation of a restaurant that offers Peruvian cuisine, which is a natural fusion of Native Peruvian, Spanish, African, Chinese and Italian culinary traditions. These include rotisserie chicken, beef, and seafood dishes using proprietary sauces and rubs served in an authentic welcoming atmosphere. We offer three (3) types of franchise models: Pollo Inka Express (sit-down with drive-thru restaurant); Inka Wasi (fast casual restaurant); and El Pollo Inka (full sized restaurant).

We offer two (2) franchise programs for our franchisees: (1) opening a single Inka location and (2) for opening multiple Inka locations:

The table below illustrates the estimated initial investment for a single start-up Inka franchised restaurant:

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT REQUIRE THAT MOST DISPUTES BE SUBMITTED TO LITIGATION/ARBITRATION IN CLARK COUNTY, NEVADA. OUT OF STATE LITIGATION/ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE RESOLUTION FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE/ARBITRATE WITH US IN NEVADA THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT NEVADA LAW GOVERNS THE AGREEMENT, AND NEVADA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THIS IS A NEW FRANCHISE OFFERING. THE FRANCHISOR HAS ONLY BEEN IN BUSINESS FOR A SHORT PERIOD OF TIME (SINCE SEPTEMBER 5, 2014). FRANCHISOR HAS NOT YET BEGUN OPERATING ACTIVITIES. THEREFORE, THERE IS NO OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
4. THE FRANCHISOR HAS (\$26,587) IN NET EQUITY AND IS UNDERCAPITALIZED. THE ESTIMATED COSTS OF INITIAL INVESTMENT FOR FRANCHISEES FOR A SINGLE UNIT IS \$197,600 TO \$893,000. THEREFORE, THE FRANCHISOR MAY NOT BE ABLE TO MEET ALL OF ITS BUSINESS OPERATING OBLIGATIONS OR FULFILL ALL OF ITS PREOPENING OBLIGATIONS TO FRANCHISEES.
5. YOUR SPOUSE MAY BE REQUIRED TO SIGN A PERSONAL GUARANTEE, MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
