We are in receipt of your comment letter regarding Inta Juice Franchising LLC ("Franchisor") dated December 26, 2017. We made the following revisions to the FDD in accordance with your correspondence:

- 1. A corrected copy of the Franchisor's Costs and Sources of Fund document is included with this response.
- 2. We have revised Item 8 to state none of Franchisor's officers own an interest in any supplier, as requested.
- 3. The FDD has been updated with audited financial statements, as of December 31, 2017, as requested.
- 4. Per your request, enclosed is a copy of the License Agreement between Inta Juice Franchising LLC's affiliate, Inta Juice Acquisitions, LLC, and Shindelar Enterprises, Inc. Also included are two Extension Amendments to the License Agreement.
