4. THE FAILURE TO ATTAIN MINIMUM GROSS SALES IS A DEFAULT UNDER THE MEMBER SERVICES AGREEMENT, WITH NO OPPORTUNITY TO CURE, AND IS GROUNDS FOR TERMINATION BY US.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
