The franchise offered is for the operation of an INTELLITURF® business within a particular geographic territory. The business features the sale of synthetic turf, as well as the option to design, install and/or offer consulting services related to the installation of synthetic turf for golf green design, recreational uses and landscape solutions.

The total initial investment necessary to begin operation of an INTELLITURF business is from \$83,745 to \$157,770. This includes \$50,000 to \$57,500 that must be paid to us or our affiliates. If you are an existing franchisee acquiring an additional franchise, the total initial investment necessary to begin operation of an INTELLITURF business is from \$65,745 to \$139,770. This includes \$32,000 to \$36,000 that must be paid to us.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. TO THE EXTENT NOT SUBJECT TO MEDIATION OR ARBITRATION, ANY CAUSE OF ACTION, CLAIM, SUIT OR DEMAND MUST BE BROUGHT IN THE FEDERAL DISTRICT COURT OR COUNTY DISTRICT COURT IN THE CITY OF OUR CORPORATE HEADQUARTERS (CURRENTLY, ATLANTA, GEORGIA), ALTHOUGH THE GOVERNING LAW MAY PROVIDE THAT ANY PROVISIONS OF THE FRANCHISE AGREEMENT DESIGNATING JURISDICTION OUTSIDE OF THE STATE ARE VOID. IT MAY COST MORE TO LITIGATE WITH US IN THE CITY OF OUR CORPORATE HEADQUARTERS THAN IN YOUR HOME STATE.

5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
