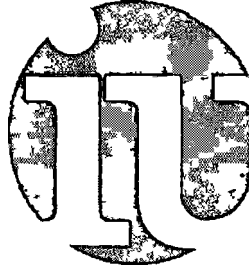

As a franchisee you will operate a business specializing in language translation and interpretation services for individuals and businesses under the name INTERPRETERS UNLIMITED®

The total investment necessary to begin operation of an INTERPRETERS UNLIMITED® business is between \$37,250 to \$84,800. This includes between \$29,500 and \$30,500 that must be paid to the franchisor or its affiliate(s).
