This includes an initial franchise fee of \$1,995 and a one-time minimum Marketing Fee of \$1,500 in exchange for which we will offer you one or more Account Commitments with a minimum aggregate Account Volume of at least \$500/month.

You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, such as a lawyer or an accountant.
