We franchise the right to operate "Iron Tribe Fitness" fitness training facilities (each, a "Facility" or "Franchised Business") focused on providing a group oriented fitness and workout Facility, using the Iron Tribe Fitness business system.

The total investment necessary to begin operation of an Iron Tribe Fitness franchise is \$305,000 to \$438,500. This includes an initial franchise fee of \$42,000 that must be paid to us.

We offer qualified individuals the right to own and operate multiple Facilities in a designated development area by entering into a Multi-Unit Development Agreement ("MDA"). The total initial investment necessary to begin operating under the MDA will vary depending on the number of Facilities to be opened in your designated area (a "Development Area"). The total estimated initial investment for three Facilities ranges from \$330,000 to \$463,500, which includes \$67,000 you must pay to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
