The total investment necessary to begin operation of an Izsam® franchised business is from \$72,075 to \$95,400. This includes \$31,150 that must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN NEBRASKA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT THE LAWS OF NEBRASKA GOVERN THE AGREEMENT. NEBRASKA LAW MAY NOT BE AS FAVORABLE AS THE LAWS OF YOUR OWN STATE. YOU MAY WANT TO COMPARE THE LAWS OF THE STATE OF NEBRASKA, WHICH GOVERN THE FRANCHISE AGREEMENT, WITH THE STATE AND LOCAL LAWS IN YOUR STATE.

- 4. YOU MUST MAINTAIN MINIMUM SALES PERFORMANCE LEVELS. YOUR ABILITY TO MAINTAIN THESE LEVELS MAY RESULT IN LOSS OF ANY TERRITORIAL RIGHTS YOU ARE GRANTED, TERMINATION OF YOUR FRANCHISE, AND LOSS OF YOUR INVESTMENT.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of this franchise.
