Under this Disclosure Document, we offer franchises for the operation of quick service restaurants and express restaurants operating under the name “The Taco Maker” or “Jake’s Over the Top”. “The Taco Maker” restaurants offer Mexican food, including tacos, burritos, nachos, and taco salads, as well as beverages and other complementary food items. “Jake’s Over the Top” restaurants offer distinctive ice cream shakes, charbroiled burgers, fries, cheese fries, chicken sandwiches, beverages and other complementary food items. If your restaurant will be located in a shopping mall food court setting, it will be a standard restaurant. If your restaurant will be located in a shopping mall but outside of the food court, it will be an express restaurant.

The total investment necessary to begin operation of a standard Restaurant is \$172,500 to \$331,500. This includes \$38,500 that must be paid to the franchisor and/or its affiliate. The total investment necessary to begin operation of an express Restaurant is \$139,000 to \$229,000. This includes \$21,000 that must be paid to the franchisor and/or its affiliate. The total investment necessary to begin operation of a standard or express Restaurant in a mall location is \$134,000 to \$252,500. This includes between \$21,000 to \$38,500 that must be paid to the franchisor and/or its affiliate.

If you qualify to be a Multi-Unit Operator to develop multiple Restaurants within a specific area, you will pay a multi-unit rights fee equal to 100% of the initial franchise fee for the first Restaurant to be developed plus 50% of the initial franchise fee for each additional Restaurant to be developed under the Multi-Unit Operator Agreement. The multi-unit rights fee is applied pro rata to the initial franchise fees due for each restaurant to be developed after the first. Your estimated initial investment will vary based on the number of restaurants to be developed.

We are offering to certain qualified people the right to become a Development Agent. A Development Agent must pay a Development Agent Rights fee that will begin at \$100,000 and will depend on the size of the development area. The estimated initial investment will vary based on the number of Restaurants to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale

or grant. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. 1. **THE FRANCHISE, MULTI-UNIT OPERATOR AND DEVELOPMENT AGENT AGREEMENTS REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN PUERTO RICO. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH THE FRANCHISOR IN PUERTO RICO THAN IN YOUR HOME STATE.**
2. **THE FRANCHISE, MULTI-UNIT OPERATOR AND DEVELOPMENT AGENT AGREEMENTS STATE THAT PUERTO RICO LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.**
3. **THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**
