The franchise is for the operation of midscale and upper midscale lodging facilities in the select-service segments, under the trademark Jameson Inn® and certain other proprietary marks.

The total investment to convert an existing inn into a 70-room Jameson Inn is \$184,700 to $\frac{1,043,5001,046,000}{1,046,000}$. This estimate includes the \$23,500 to $\frac{26,00028,500}{28,500}$ that must be paid to us or our affiliate or us. The total investment for a new construction 70-room Jameson Inn is $\frac{4,796,7004,814,200}{4,814,200}$ to $\frac{8,392,0008,465,500}{8,500}$, excluding site acquisition and preparation. This estimate includes the \$23,500 to $\frac{25,00028,500}{28,500}$ that must be paid to us or our affiliate or us.

This disclosure document summarizes certain provisions of your franchise agreement (which we call a Membership Agreement) and other information in plain English. Read this disclosure document and all accompanying agreements carefully. 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION OR LITIGATION ONLY IN FLORIDA. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN FLORIDA THAN IN YOUR HOME STATE.

2. THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. ANY INDIVIDUALS OWNING 20% OR GREATER LEGAL OR BENEFICIAL INTEREST IN THE FRANCHISEE ARE REQUIRED TO SIGN A GUARANTY OF YOUR OBLIGATIONS AND BE BOUND BY THE PROVISIONS OF OUR FRANCHISE AGREEMENT. THE SPOUSES OF THE GUARANTORS MAY ALSO BE REQUIRED TO CONSENT TO THE GUARANTY, WHICH PLACES THE SPOUSES' MARITAL ASSETS AT RISK.

<u>4.</u> 3.-THE TERRITORY IS NOT EXCLUSIVE. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM FRANCHISOR OWNED OUTLETS OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS FRANCHISOR CONTROLS.

<u>5.</u> 4.–WHILE THE FRANCHISE AGREEMENT HAS A TERM OF TWENTY YEARS, THE FRANCHISE AGREEMENT PROVIDES FOR A TERMINATION WITHOUT CAUSE BY EITHER PARTY AS OF THE 3RD, 6TH, 9TH, 12TH, 15TH AND 18TH ANNIVERSARY OF THE BILLING START DATE OF THE FRANCHISE AGREEMENT.

<u>6.</u> <u>5.</u> THIS FRANCHISE AGREEMENT PROVIDES THAT IT WOULD BE DIFFICULT IF NOT IMPOSSIBLE TO DETERMINE THE AMOUNT OF CERTAIN DAMAGES THAT WE WOULD SUFFER IF THIS AGREEMENT IS TERMINATED. THEREFORE, FRANCHISEE AGREES TO A PREDETERMINED AMOUNT TO COVER CERTAIN DAMAGES.

<u>7.</u> 6.-THIS FRANCHISE AGREEMENT PROVIDES THAT YOU AGREE THAT WE WILL NOT BE REQUIRED TO POST A BOND TO OBTAIN INJUNCTIVE RELIEF AND THAT IF NONETHELESS REQUIRED BY A COURT OF COMPETENT JURISDICTION, A BOND OR SURETY OF \$1,000 WOULD BE ADEQUATE.

8. 7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
