ITEM 1. THE FRANCHISOR, ITS PREDECESSORS, AND AFFILIATES

To simplify the language in this Offering Circular, "JPE" means Jan-Pro Enterprises, LLC, the franchisor. "We", "us", and "our" also refer to Jan-Pro Enterprises, LLC. "You" and "your" mean the person who buys the franchise, the franchisee. If the purchaser of the franchise is a partnership, corporation, or other entity, "you" includes the franchisee's owners, who must join the Franchise Agreement and are jointly and severally liable for the franchisee's obligations to us.

All initially capitalized terms appearing in this Offering Circular have the meanings ascribed to them in the Franchise Agreement attached as Exhibit A, unless otherwise defined.

Franchisor's Corporate Information

We are a Delaware limited liability company that was organized on February 15, 2005, and do business under the name **Jan-Pro** and **Jan-Pro Cleaning Systems**. Our principal business address is 11605 Haynes Bridge Road, Suite 425, Alpharetta, Georgia 30004-8695.

Our agent for service of process is listed on the Acknowledgment of Receipt on the last page of this Offering Circular.

Predecessors and Affiliates

We do not have a predecessor.

Our affiliate Jan-Pro Franchising International, Inc. (the "Master Franchisor"), granted us the right to use the System you will use to operate your franchised business. The System includes the Jan-Pro service mark and related intellectual property. The Master Franchisor is a Massachusetts corporation that was incorporated in April, 1995. The Master Franchisor does business as Jan-Pro and Jan-Pro Cleaning Systems. The Master Franchisor's principal business address is 11605 Haynes Bridge Road, Suite 425, Alpharetta, Georgia 30004-8695. The Master Franchisor has never operated a business similar to the Franchised Business. The Master Franchisor has offered franchises for Jan-Pro master franchises since 1995, but does not offer unit franchises that operate this type of business-since-1995. The Master Franchisor has not offered franchises in any other type of business. The Master Franchisor has executed a Guaranty of Performance, under which it is assuming the obligations described in Item 21.

We have three affiliates that sell Jan-Pro franchises: Jan-Pro of Phoenix, LLC; Jan-Pro of San Antonio, LLC; and Jan-Pro of North Chicago, LLC.

Jan-Pro of Phoenix, LLC, is a Delaware limited liability company organized on April 10, 2007, and conducts business as **Jan-Pro** of **Phoenix**. Its principal business address is 11605 Haynes Bridge Road, Suite 425, Alpharetta, Georgia 30004-8695. It is the Jan-Pro regional master franchisee for Phoenix, Arizona, operating under a Regional Master Franchise Agreement entered with the Master Franchisor on May 1, 2007. It has never operated a business similar to the Franchised Business
