The franchise being offered to you is a license to operate a JAN-PRO franchised business in accordance with Franchisor's System of operating a janitorial and building maintenance service to commercially clean offices and buildings, employing the "JAN-PRO" trademarks and service marks

The total investment necessary to begin operation of a JAN-PRO franchised business is approximately \$3,075 to \$50,275 This includes \$2,800 to \$44,000 that must be paid to the Franchisor

ADDITIONAL REGULATIONS REQUIRED BY THE STATE OF CALIFORNIA

California Business and Professions Code Sections 20000 through 20043 provide rights to the Franchisee concerning termination or non-renewal of a franchise If the franchise agreement contains a provision that is inconsistent with the law, the law will control

The franchise agreement provides for termination upon bankruptcy This provision may not be enforceable under federal bankruptcy law (11 U S C A Sec101 et seq)

The franchise agreement contains a covenant not to compete that extends beyond termination of the franchise This provision may not be enforceable under California law

The Franchise Agreement contains a liquidated damages clause Under California Civil Code Section 1671, certain liquidated damages clauses are unenforceable

The franchise agreement requires binding mediation The mediation will occur in California with costs being borne by you, if you lose This provision may not be enforceable under California law

Neither the Franchisor, nor any person or franchise broker in Item 2 of the Disclosure Document is subject to any currently effective order of any national securities association or national securities exchange, as defined in the Securities Exchange Act of 1934, 15 USCA 78a et seq, suspending or expelling such persons from membership in such association or exchange
