- 4 THE POSSIBLE SUCCESS OF YOUR JAYNA INTERNATIONAL SUSHI BAR(S) MAY BE DEPENDENT UPON THE LOCATION OR AREA YOU CHOOSE AS WELL AS OTHER FACTORS THESE FACTORS, ALONG WITH YOUR OWN BUSINESS ABILITY IN OPERATING YOUR JAYNA INTERNATIONAL SUSHI BAR(S) AND YOUR FINANCAL AND OTHER RECOURSES ARE COMPONENTS THAT MOST LIKELY TO DETERMINE YOUR POTENTIAL SUCCESS
