As a Jerry's Wood Fired Dogs franchisee you will operate and offer within defined territories a quick serve restaurant outlet providing a full variety of hot dogs, sausages, chili, hamburgers, chicken sandwiches, specialty condiments and ingredients, and other food, beverages and related products and accessories

The total investment necessary to begin operation of a Jerry's Wood Fired Dogs restaurant outlet ranges from ~~\$313,500~~ ~~340,500~~ to ~~\$453,500~~ ~~449,000~~—This includes the \$25,000 that must be paid to the franchisor and its affiliates. The franchisor may also offer you a Multi Outlet Agreement granting a right to open one or more additional Outlets for an additional investment ("Development Fee") ranging from \$12,500 to \$50,000, all of which must be paid to the franchisor.
