The franchise is to operate a Restaurant under the "JIMMY JOHN'S®" name that features gourmet deli sandwiches, fresh baked breads, and other food and beverage products.

The total investment necessary to begin operation of a JIMMY JOHN'S® Restaurant is ~~\$300,500~~330,500 to ~~\$489,500~~519,500 (including initial real estate lease costs). This includes \$30,000 to ~~\$36,500~~37,000 that must be paid to the franchisor or affiliate. If you want development rights, you must pay the franchisor a development fee equal to \$35,000 (the initial franchise fee for the first Restaurant) plus a deposit of \$25,000 for each additional Restaurant (a minimum of 4 total).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
