You, the franchisee, will list, offer and sell residential real estate, using the John L. Scott Real Estate Affiliates business system.

The total investment necessary to begin operation of a John L. Scott Real Estate Affiliates franchise is \$59,000 to \$220,000. This includes an initial franchise fee of \$15,000 that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read your entire contract carefully. Show your contract and this disclosure document to an advisor, such as a lawyer or an accountant.
