The franchisee will own and operate a Jon Smith Subs restaurant franchise offering made-to-order submarine sandwiches, grilled sandwiches, salads and other related foods and beverages

The total investment necessary to begin operation of a Jon Smith Subs Restaurant is from \$324,000 to \$632,484. These amounts include \$146,000 to \$210,484 that you must pay to the franchisor and its affiliates. The total investment necessary to begin operation of a Jon Smith Subs Restaurant as a developer under the Franchise Development Agreement is from \$399,000 to \$902,484. These amounts include \$221,000 to \$480,484 that you must pay to the franchisor and its affiliates, although if you agree to develop more than 20 Restaurants the amounts you pay to the franchisor will be higher. For the development of more than 20 Jon Smith Subs Restaurants, these amounts would also include an additional \$10,000 for each Restaurant to be developed in excess of 20 Restaurants, that must be paid to the franchisor and its affiliates.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
