The franchise offered is Montessori children's education services emphasizing learning through all five senses, where children learn at their own individual pace and according to their own choice of activities from hundreds of possibilities. The unique feature of Joyous Montessori schools is that they go beyond the basic Montessori tenets. The programs were developed keeping the different age ranges of children in mind, ranging from simple motor skill development for the infants, verbal and social skill development for pre-toddlers, math, language and geography for toddlers and traditional reading, writing and math skills for older children. The franchise also offers a unique enrichment program consisting of Spanish, Music & Movement, Yoga, Computer Lab, Gymnastics, Sports skill development, Book Club and other similar programs.

The total investment necessary to begin operation of a Joyous Montessori franchise is \$418,100 to \$5,894,250 This includes the \$70,000 franchise fee that must be paid to the franchisor or affiliate.
