We offer 2 franchise programs

1 A single juice bar The estimated initial investment to begin operation of a **JUICE IT UP**® Unit is between approximately \$152,144 and \$377,821 as described at Item 7 The low end of this range includes a \$7,500 initial franchise fee for a kiosk Unit and the high end of this range includes an initial franchise fee of \$25,000 for a full-sized Unit These sums do not represent your total investment in the **JUICE IT UP**® juice bar franchise

2 Multi-Unit development of a minimum of 3 Units, within a defined area pursuant to an Area Development Agreement The initial franchise fee is \$25,000 for the first full-sized Traditional Unit, \$20,000 for the 2nd full-sized Unit and \$15,000 for the 3rd and all subsequent full-sized Units opened under an Area Development Agreement

Franchise Disclosure Document - California

The initial franchise fee for a kiosk Unit is \$7,500, and is not discounted for any reason. There is a non-refundable initial area development fee equal to ½ of the total initial franchise fees for the total number of Units you purchase. We will credit this area development fee toward the initial franchise fee due under each Franchise Agreement at a maximum rate of ½ of the initial franchise fee owed for each Unit until the entire area development fee has been credited. The balance remaining on the initial franchise fee for each Unit is paid when you sign each Franchise Agreement. The initial investment range to begin operation under an Area Development Agreement is estimated at approximately \$159,644 to \$395,621 which includes the establishment of the 1<sup>st</sup> of 3 Units only, not all costs for establishment of all 3 Units as this is an “initial investment” figure not a full build-out figure. The low end of this range includes the applicable initial franchise fee and area development fee of \$15,000 for 3 kiosks, and the high end of this range includes \$42,500 for 3 full-sized Units. Your estimated initial investment to establish and begin operation of more than 3 Units, or a combination of full-sized Units and kiosk Units can be calculated using the figures provided in Item 7.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an Affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
