We offer franchise opportunities to own and operate one or more authentic juice bars serving fresh-squeezed juices, cold-pressed bottled juices, smoothies, acai and pitaya bowls, and other snacks to an increasingly health-conscious world

We offer 2 franchise programs

- A single juice bar The estimated initial investment to begin operation of a **JUICE IT UP®** Unit is between approximately \$216,400 and \$378,300 as described at Item 7 These amounts include an initial franchise fee of between \$10,000 to \$25,000 per Unit which must be paid to LLJ Franchise, LLC These sums do not represent your total investment in the **JUICE IT UP®** juice bar franchise
- Multi-Unit development of a minimum of 3 Units, within a defined area pursuant to an Area Development Agreement. The initial franchise fee is \$25,000 for the first full-sized Traditional Unit, \$20,000 for the 2nd full-sized Unit and \$15,000 for the 3rd and all subsequent full-sized Units opened under an Area Development Agreement. There is a non-refundable initial area development fee equal to ½ of the total initial franchise fees for the total number of Units you purchase. We will credit this area development fee toward the initial franchise fee due under each Franchise Agreement at a maximum rate of ½ of the initial franchise fee owed for each Unit until the entire area development fee has been credited. The balance remaining on the initial investment range to begin operation under an Area Development Agreement. The initial investment range to begin operation under an Area Development Agreement is estimated at approximately \$226,400 to \$395,800 which includes the establishment of the 1st of 3 Units only, not all costs for establishment of all 3 Units as this is an "initial investment" figure not a full build-out figure.
