The Franchise is an indoor entertainment facility equipped with inflatables, providing party and play services to children using the “Jump!Zone” trademarks.

The total investment necessary to begin operation of a Jump!Zone Center ranges from \$299,500 to \$684,600, including \$53,000 you must pay the Franchisor. This sum does not include construction of a new building, if needed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
