The franchise offered is for the operation of a full service pet spa that specializes in pet grooming services for all types of domestic animals and is complemented with a small retail center. This is a service-oriented business that provides individualized grooming services for pets in a distinctive spa-like environment that uses alternative healing techniques to manage pet anxiety while operating under the name "Just 4 Paws[™] Pet Spa". The total estimated initial investment required to begin operation of a Just 4 Paws[™] Pet Spa franchise ranges from \$74,100 to \$138.490 which will depend on a number of factors that are further discussed in Item 7. These figures include the Initial Franchise Fee of \$18,000 (as discussed in Item 5) that must be paid to the Franchisor or affiliate. Additional franchises may be available for a reduced initial franchise fee of \$9,000 per Franchise.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
