This franchise is for the operation of a luxury pet care facility offering dog daycare and boarding services under the name and mark “K-9 Resorts Daycare & Luxury Hotel”.

The total investment necessary to begin operation of a K-9 Resorts franchise is \$695,500 to \$1,046,200. This includes between \$35,300 and \$40,300 that must be paid to the franchisor and/or its affiliate.

We may also offer to certain qualified people the right to develop multiple K-9 Resorts franchises under a Multi-Unit Operator Agreement. The total investment under a Multi-Unit Operator Agreement to develop three K-9 Resorts franchises is \$2,098,500 to \$3,136,100. This includes \$115,300 that must be paid to the franchisor and/or its affiliate, as appropriate.

We may also offer to certain qualified people the right to become a Development Agent. A Development Agent will pay a Development Agent Rights Fee that will be negotiated between you and us depending on the number of franchises you will develop, the size of your development area and other factors. A Development Agent must open and operate at least one K-9 Resort, and a Development Agent will share in some of the fees paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

OUT OF STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT MAY ALSO COST MORE TO MEDIATE AND ARBITRATE WITH US IN NEW JERSEY THAN IN YOUR OWN STATE.**
