The business involves providing hair removal and beauty services to customers, obtaining new customers, and management and administration associated with operating a hair removal and beauty services business.

The total investment necessary to begin operation of a Get Threaded Brow & Beauty Bar or Salon franchise is \$93,100- \$294,250. This includes what must be paid to the franchisor or affiliate.
