We offer *Kahala Coffee Traders* franchises. As a franchisee, you will operate a restaurant called *Kahala Coffee Traders* preparing, specializing in, and serving a variety of hot, cold, and iced beverages including coffee, espresso and tea, hot chocolate; baked goods including pastries, muffins, donuts, cookies, and brownies; fresh fruit; parfaits; breakfast sandwiches and oatmeal; sandwiches; salads and related fast food menu items.

The total investment necessary to begin operation of a *Kahala Coffee Traders* franchise ranges from \$95,410 to \$406,750 for a traditional franchise restaurant, and from \$79,010 to \$277,250 for a non-traditional franchise restaurant. This includes \$15,800 to \$85,250 for a traditional location and \$7,400 to \$59,750 for a non-traditional location that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

MUCH OF THE SUPPORT, TRAINING, AND PRE AND POST OPENING OBLIGATIONS TO FRANCHISEES, AND MARKETING AND ADVERTISING SUPPORT SERVICES WILL BE PROVIDED BY AN AFFILIATE OF THE FRANCHISOR, KAHALA MANAGEMENT, L.L.C. THE FINANCIAL STATEMENTS OF KAHALA MANAGEMENT, L.L.C. ARE NOT CONTAINED IN THE FRANCHISE DISCLOSURE DOCUMENT AND WILL NOT BE PROVIDED TO FRANCHISEES.
