The franchised business is to operate an indoor children's play center and entertainment business under the trade name Kanga's Indoor Playcenter.

The total investment necessary to begin operation of a Kanga's franchise is \$388,250 to \$699,200. This includes \$42,500 that must be paid to the franchisor or affiliate.
