The franchised business is to operate an indoor children's play center and entertainment business under the trade name Kanga's Indoor Playcenter.

The total investment necessary to begin operation of a Kanga's franchise is \$418,500 to \$749,500. This includes \$51,500 that must be paid to the franchisor or affiliate.
