The franchise is for the establishment and operation of a "Key West<sup>TM</sup>" branded lodging facility ("Key West Lodging Facility").

The total investment necessary to begin operation of a Key West Lodging Facility franchised business is between \$2,457,899 and \$7,390,700 for a newly constructed hotel and between \$29,899 and \$620,700 for the conversion of an existing hotel. This includes between \$18,899 and \$30,700 that must be paid to the franchisor or its affiliates(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
