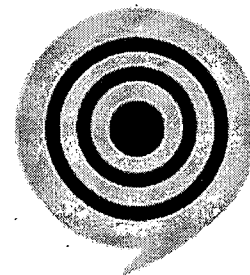

Keylingo Franco, LLC is offering franchises to establish and operate a translation and interpretation services business using the Keylingo Translation System and the Licensed Marks. The total investment necessary to begin operation of a franchised Keylingo Business is \$56,000 to \$76,000. This includes \$40,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

THE FRANCHISE AGREEMENT REQUIRES YOU TO MEDIATE WITH US ALL DISPUTES FOR WHICH WE DO NOT SEEK INJUNCTIVE OR EQUITABLE RELIEF AT A LOCATION ON WHICH WE AGREE OR, ABSENT AGREEMENT, IN ATLANTA, GEORGIA. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US THAT WE DO NOT RESOLVE IN MEDIATION THROUGH LITIGATION IN ATLANTA, GEORGIA. OUT-OF-STATE MEDIATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE A DISPUTE OR TO DEFEND A LAW SUIT IN GEORGIA THAN IN YOUR HOME STATE.

THE FRANCHISE AGREEMENT STATES THAT GEORGIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

WE WERE FORMED ON MARCH 21, 2010 AND HAVE A BRIEF OPERATING HISTORY. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPOTUNITY.

THE FRANCHISOR (1) IS A DEVELOPMENT STAGE COMPANY WITH LIMITED OPERATING HISTORY TO ASSIST A PROSPECTIVE FRANCHISEE IN DECIDING TO MAKE THIS INVESTMENT, AND (2) HAS LIMITED FINANCIAL RESOURCES WHICH MIGHT NOT BE ADEQUATE TO FUND THE FRANCHISOR'S PRE-OPENING OBLIGATIONS TO EACH FRANCHISEE AND PAY OPERATING EXPENSES.
