Keyrenter Property Management businesses provide full service real estate management and rental services, focusing largely on single-family homes and condominium owners, as well as related property management services such as signing leases, collecting rents, and performing and coordinating maintenance and repairs.

We offer two franchise programs:

<u>Standard Franchise:</u> The total investment necessary to begin operation of a single standard Keyrenter Property Management franchise ranges from \$65,390 - \$92,895. This includes \$32,000 that must be paid to the franchisor or affiliate.

<u>Small Market Franchise:</u> The total investment necessary to begin operation of a single Small Market Keyrenter Property Management franchise ranges from \$50,390 to \$77,895. This includes \$17,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or affiliates in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

MANY FRANCHISE AGREEMENTS DO NOT ALLOW YOU TO RENEW UNCONDITIONALLY AFTER THE INITIAL TERM EXPIRES. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION AND LITIGATION ONLY IN UTAH. OUT OF STATE MEDIATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND LITIGATE WITH US IN THE STATE THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT REQUIRES THAT UTAH LAW GOVERNS THE AGREEMENT, AND UTAH LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. FRANCHISEES ARE SUBJECT TO A MONTHLY ROYALTY FEE OF 7% ON TOTAL GROSS REVENUES OR \$250, WHICHEVER IS GREATER. IF, HOWEVER, THE PAYMENT IS RECEIVED AFTER THE 15TH OF THE MONTH THAT MONTH'S ROYALTY FEE WILL INCREASED TO 10% OF TOTAL GROSS REVENUES.
- 4. YOU MUST MAINTAIN MINIMUM SALES PERFORMANCE LEVELS. IF YOU FAIL TO DO SO, THE FRANCHISOR COULD TERMINATE YOUR AGREEMENT RESULTING IN THE LOSS OF YOUR INVESTMENT.
- 5. IF YOU ARE A CORPORATION OR OTHER BUSINESS ENTITY, ANYONE WHO OWNS A 5% OR GREATER INTEREST IN THE ENTITY MUST PERSONALLY GUARANTEE THE PERFORMANCE OF ALL OF YOUR OBLIGATIONS UNDER THE FRANCHISE AGREEMENT AND AGREE TO BE PERSONALLY LIABLE FOR YOUR BREACH OF THE FRANCHISE AGREEMENT. THIS REQUIREMENT PLACES THE PERSONAL ASSETS OF THE FRANCHISE OWNER(S) AT RISK.



- 6. WE WERE FORMED ON DECEMBER 10, 2013 AND HAVE A BRIEF OPERATING HISTORY. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.
- 7. THE FRANCHISOR'S FINANCIAL STATEMENTS DATED DECEMBER 31, 2016 REFLECT THAT CURRENT LIABILITIES SUBSTANTIALLY EXCEED CURRENT ASSETS. AS PER THE BALANCE SHEET, THE FRANCHISOR HAD A MEMBER'S CAPITAL DEFICIENCY OF (\$236,292).
- 8. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$50,400 TO \$89,500. THIS AMOUNT EXCEEDS THE FRANCHISOR'S MEMBER'S EQUITY AS OF DECEMBER 31, 2016, WHICH IS (\$236,292).
- 9. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
