Kidcreate businesses offer children's art lessons in a class, camp, and party format that focus on art education for children from ages 18 months through 12 years, either in a studio or a mobile "on the go" format ("Kidcreate Business(es)").

The total investment necessary to begin operation of a single Kidcreate studio franchised business is between \$110,705 and \$266,270. This includes between \$62,905 and \$67,520 that must be paid to the franchisor or its affiliate(s). Kidcreate franchisees may also purchase the right to develop multiple Kidcreate studio franchised businesses. The total investment necessary to begin operation of three Kidcreate studio franchised businesses ("Standard 3 Franchise") is between \$290,115 and \$756,810. This includes between \$146,715 and \$160,560 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of five Kidcreate studio franchised businesses ("Standard 5 Franchise") is between \$444,525 and \$1,222,350. This includes between \$205,525 and \$228,600 that must be paid to the franchised businesses ("Standard 10 Franchise") is between \$805,550 and \$2,361,200. This includes between \$327,550 and \$373,700 that must be paid to the franchisor or its affiliate(s).

The total investment necessary to begin operation of a single Kidcreate mobile franchised business is between \$64,765 and \$95,490. This includes between \$54,405 and \$57,790 that must be paid to the franchisor or its affiliate(s). Kidcreate franchisees may also purchase the right to develop multiple Kidcreate mobile franchised businesses. The total investment necessary to begin operation of three Kidcreate mobile businesses ("Standard 3 Franchise") is between \$169,295 and \$261,470. This includes between \$138,215 and \$148,370 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of five Kidcreate mobile franchised businesses ("Standard 5 Franchise") is between \$248,825 and \$402,450. This includes between \$197,025 and \$213,950 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of ten Kidcreate mobile franchised businesses ("Standard 10 Franchise") is between \$422,650 and \$729,900. This includes between \$319,050 and \$352,900 that must be paid to the franchisor or its affiliate(s).

How to Use This Franchise Disclosure Document

Here are some questions you may be asking about buying a franchise and tips on how to find more information:

QUESTION	WHERE TO FIND INFORMATION
How much can I earn?	Item 19 may give you information about outlet sales, costs, profits or losses. You should also try to obtain this information from others, like current and former franchisees. You can find their names and contact information in Item 20 or Exhibit G.
How much will I need to invest?	Items 5 and 6 list fees you will be paying to the franchisor or at the franchisor's direction. Item 7 lists the initial investment to open. Item 8 describes the suppliers you must use.
Does the franchisor have the financial ability to provide support to my business?	Item 21 or Exhibit D includes financial statements. Review these statements carefully.
Is the franchise system stable, growing, or shrinking?	Item 20 summarizes the recent history of the number of company-owned and franchised outlets.
Will my business be the only Kidcreate business in my area?	Item 12 and the "territory" provisions in the franchise agreement describe whether the franchisor and other franchisees can compete with you.
Does the franchisor have a troubled legal history?	Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.
What's it like to be a Kidcreate franchisee?	Item 20 or Exhibit G lists current and former franchisees. You can contact them to ask about their experiences.
What else should I know?	These questions are only a few things you should look for. Review all 23 Items and all Exhibits in this disclosure document to better understand this franchise opportunity. See the table of contents.
