The total investment necessary to begin operation of a single Kidcreate studio franchised business is between \$122143,960 and \$279,050295,090. This includes between \$62,660 and \$67,800 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of a single Kidcreate mobile "on the go" franchised business is between \$64,520 and \$95,000. This includes between \$54,160 and \$58,300 that must be paid to the franchisor or its affiliate(s). Kidcreate franchisees may also purchase the right to develop multiple Kidcreate franchised businesses.
