The total investment necessary to begin the operation of a **Kiddie Academy**® Franchise is \$425,000 - \$920,000 for a <u>leased</u> Kiddie Academy franchised location, and \$3,550,000 - \$4,163,000 for a <u>purchased</u> Kiddie Academy franchised location. This includes \$135,000 in Initial Fees that must be paid to the franchisor or an affiliate.
