The franchise is to operate a transportation business for children ages 3-18 under the trade name "Kids Kab".

The total investment necessary to begin operation of a Kids Kab franchise is \$84,600 to \$175,583. This includes \$30,000 that must be paid to the franchisor or affiliate.
