KidsPark[®] franchisees operate hourly, drop-in childcare centers, preschool programs and private parties for children from 2 to 12 years of age.

The estimated total investment necessary to begin operation of a *KidsPark*[®] center franchise is \$185,000 to \$340,000, including the initial franchise fee of \$22,500 that must be paid to the franchisor. The franchise fee for multiple *KidsPark*[®] centers purchased at the same time is discounted as described in Item 5 below.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY FACE-TO-FACE MEETING AND ARBITRATION ONLY IN CALIFORNIA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEET AND ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. YOUR TERRITORY EXCLUSIVITY MAY, AT OUR OPTION, DEPEND UPON YOUR MAINTAINING AN ENROLLMENT OF 1,400 FAMILIES, AND AN ANNUAL AVERAGE OF 40 NEW FAMILIES PER MONTH, AFTER THE 20TH MONTH OF OPERATION.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
