We offer franchises for the operation of businesses that provide art instruction and products to children and adults under the mark KidzArt®.

The total investment necessary to begin operation of a KidzArt franchised business is \$46,055 to \$52,755 (excluding rent costs). This includes \$41,345 that must be paid to the franchisor or its affiliate.

We also offer franchises for the operation of businesses that provide educational and technology enrichment programs for children ages 4 to 14 through a uniform system that includes quality products and proprietary curricula and business format under the mark Club Scientific®.

The total investment necessary to begin operation of a Club Scientific franchised business is \$45,285 to \$79,410 (excluding rent costs). This includes \$27,925 to \$28,425 that must be paid to the franchisor or its affiliate.

We also offer franchisees the option to purchase both a KidzArt franchised business and Club Scientific franchised business for a reduced initial fee. The total investment necessary to begin operation of a Co-Branded KidzArt and Club Scientific franchised business is \$72,690 to \$105,390 (excluding rent costs). This includes \$55,270 to \$55,770 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Many franchise agreements do not allow you to renew unconditionally after the initial term expires. Please consider the following risk factors before you buy this franchise:

- 1. THE KIDZART FRANCHISE AGREEMENT AND CLUB SCIENTIFIC FRANCHISEE REQUIRE YOU TO RESOLVE DISPUTES WITH US BY MEDIATION ONLY IN MICHIGAN. OUT-OF-STATE MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE WITH US IN MICHIGAN THAN IN YOUR OWN STATE. THE FRANCHISE AGREEMENT STATES THAT MICHIGAN LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOUR SPOUSE MUST ALSO SIGN A GUARANTEE MAKING YOUR SPOUSE JOINTLY AND INDEPENDENTLY LIABLE FOR THE FINANCIAL OBLIGATIONS UNDER THE FRANCHISE AGREEMENT. THIS GUARANTEE PLACES YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
- YOU MUST MAINTAIN MINIMUM SALES PERFORMANCE LEVELS, WHICH MAY BE INCREASED ANNUALLY. IF YOU FAIL TO DO SO, YOU COULD LOSE YOUR EXCLUSIVE TERRITORY OR THE FRANCHISOR COULD REDUCE THE SIZE OF YOUR TERRITORY.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
