Your business would consist of a retail outlet operated from a fixed location that serves traditional Thai entrees curries and fried lice specialties. Restaurants are also located in "non-traditional" venues such as food courts, convenience stores airports or within institutional settings where the Restaurant operator does not fully control access or hours of operation.

The total investment necessary to begin operation of a King of Thai Noodle franchised business is \$304 700 – \$413 850 This includes \$30 000 that must be paid to the franchisor
