Koala Associates, LLC will offer to dentists and other qualified persons or entities a franchise for the operation of a Koala Center for Sleep Disorders ("<u>KCSD</u>") Franchise that provides patients with a variety of services in the treatment of orofacial pain, such as temporomandibular joint disorders, and sleep disorders, such as obstructive sleep apnea and snoring, and offers consumer products, such as pillows, TENS units, appliance cleaning products, anti-snore aids, bed sheets, sleep masks, sleep-related music and aromatherapy products, and other services and products that we approve from time to time, under the trade name and service mark "KOALA CENTER FOR SLEEP DISORDERS" and related trademarks, service marks and logos (a "<u>KCSD Franchise</u>"). Certain franchisees may also offer additional services such as weight loss programs and positive airway pressure ("<u>PAP</u>") therapies.

The total investment necessary to begin operation of a KCSD Franchise ranges from \$216,217 to \$414,538. This includes \$58,245 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
