The Franchisee will own and operate a casual dining restaurant emphasizing pizza cones with a variety of specialty fillings, including classic pizza ingredients, salads and drinks. KONO USA LLC provides services to Franchisees including assistance with training, operations, advertising, purchasing and promotional techniques.

The total investment necessary to begin operation of a Kono Pizza franchise depends on the type of restaurant you choose. We offer restaurants that are stationary, location-based units ("Kiosk Units"), as well as mobile units that may be moved to and from different events or locations ("Mobile Units"). The total investment necessary to begin operation of a Kiosk Unit is between \$131,976 and \$256,686. We offer three types of Mobile Units: a food cart ("Cart"), a concession trailer ("Trailer"), and a food truck ("Food Truck"). The total investment necessary to begin operation of a Cart is between \$74,526 and \$184,836. The total investment necessary to begin operation of a Trailer is between \$91,026 and \$184,736. The total investment necessary to begin operation of a Food Truck is between \$165,026 and \$273,536. These investment estimates includes \$49,000 that must be paid to us or an affiliate. These ranges are estimates of the investment necessary to open one of the type of unit you select.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. - 2. THE FRANCHISE AGREEMENT STATES THAT NEW JERSEY LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THIS GUARANTEE PLACES YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.



- 4. YOU ARE REQUIRED TO GIVE THE FRANCHISOR CONTINUOUS ACCESS TO YOUR SECURITY CAMERAS.
- 5. PLEASE NOTE THAT 61% OF KONO USA LLC'S ASSETS ARE INTANGIBLE. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.
