The franchise offered is to operate a vaporium and lounge under the "KŪRETM" name and other trademarks that sells vaping products and services, select food and beverages, and other related products and services.

The total investment necessary to begin operation of a KŪRE Store franchise is \$338,495 to \$599,304. This includes \$74,900 to \$113,900 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation under a Multi-Unit Development Agreement is \$93,000 to \$170,000. This includes \$90,000 to \$165,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
