The Franchise offered is for the operation of a therapeutic massage center under the name "LaVida MassageTM" offering therapeutic massage services to the general public in a clean and relaxing environment The total investment necessary to begin operation of a single LaVida Massage Center franchise ranges from \$160,250 to \$290,000 This includes \$39,000 that must be paid to the franchisor or affiliate for a single unit or \$83,000 for a three unit option
