The franchise offered is for the operation of a food preparation business that offers a variety of ready to heat-and-eat freshly prepared meals using fresh, healthy ingredients and proprietary recipes. This is a food preparation business that is dedicated to making fresh and healthy meals that are ready to heat-and-eat along with a variety of beverages available for carry-out, delivery or consumption on the premises, under the name "LeanFeast®." The Initial Franchise Fee is \$15,000 with protected rights to operate in a specific area as defined by us. Additional franchises may be available for those franchises who have bought at least one franchise, at a reduced fee of \$7,500 per franchise. The total estimated initial investment required to begin operation of a LeanFeast® ranges from \$142,140 to \$232,450 depending on a number of factors that are more fully discussed in Item 7. This includes the Initial Franchise Fee of \$15,000 (as discussed in Item 5) that must be paid to the Franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale. **Note**; however, no governmental agency has verified the information contained in this document.
