The franchise offered is for the operation of an after-school enrichment center for school-aged children from kindergarten through the eighth grade providing age specific structured enrichment programs and activities to augment their regular school education in addition to summer camps programs. Each center utilizes our proprietary interactive curriculum that complements our different themed enrichment programs all of which foster academic, social and life skill development. This is an education oriented business geared towards serving families who value raising their children to be creative, problem solvers and independent thinkers, under the name "Learning Bee®". The Initial Franchise Fee is \$35,000 with the right to operate in a specific protected area as defined by us. Additional franchises for those who have bought at least one franchise will be available for a reduced fee of \$25,000 per franchise. The total investment necessary to begin operation of a Learning Bee® ranges from \$180,100 to \$436,400 depending on a number of factors that are fully discussed in Item 7. This includes the Initial Franchise Fee of \$35,000 (as discussed in Item 5) that must be paid to the Franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale.
