The Minnesota Addenda to the Disclosure Document has been amended to delete the language regarding the disclosure of the subsequent events notice. We hope that this is satisfactory to the state. California had required this language and that the subsequent events notice be disclosed in the Disclosure Document. They have been approved in California, so we are hoping to avoid the costs of an additional amendment for our client and/or comments from their home state which may jeopardize their effective status and at the same time satisfy the state of Minnesota so that they may offer franchises in that state as well.

I have attached redlined and clean copies of the above-mentioned changes. Please let us know if this is acceptable.
