LHT REVOLUTION INC. (“LHTR” or the “Franchisor”) intends to offer franchises utilizing the LHT Revolution business system. LHTR’s principal business address is 6891 Douglas Blvd, Granite Bay, CA 95746 and telephone number is (408) 472-0189.

The Leaner Healthier Teen Revolution and The Leaner Healthier Today Program (referred to hereafter as “LHT Revolution Programs”) offer to prospective franchisees (referred to as “you”) a nutrition education weight loss system and method specifically designed for adults, teens and families. The franchised business includes a marketing system, trademark, patented technology, business organization and guidelines for providing services relating to the nutrition, weight loss and exercise for healthy living for adults, teens and families (together referred to as the “LHT Revolution System”). The initial fee for a new franchise is \$25,000 and \$12,500 for a converting health or weight loss business, which is paid to LHTR in cash at the time you sign your Franchise Agreement. The total investment required to begin operation of a LHT Revolution System Franchise would range from approximately \$59,750 to \$79,000. This amount exceeds the Franchisor’s stockholders accumulated deficit as of December 31, 2014 which is (\$110,698).

This Franchise Disclosure Document (“Disclosure Document”) summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise purchase. **Note, however, that no governmental agency has verified the information contained in this document.**
