The franchise being offered is to establish and operate a Lice Lifters<sup>®</sup> lice treatment center. Lice Lifters<sup>®</sup> franchises are lice removal treatment centers that offer lice detection and removal services, and Lice Lifters<sup>TM</sup> Branded Products, which assist with, or otherwise relate to, the removal and treatment of lice, and other products and services that the franchisor designates, all under the trade name "Lice Lifters<sup>®</sup>."

The total investment necessary to begin operation of a Lice Lifters<sup>®</sup> treatment center ranges from \$68,087 to \$75,703. This includes an initial franchise fee of \$35,000 and \$5,087.00 in inventory purchases (for a total of \$40,087) that must be paid to us or our affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read your entire contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. OUT-OF-STATE MEDIATION OR ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE OR ARBITRATE WITH US IN PENNSYLVANIA THAN IN YOUR OWN STATE.
