We franchise the right to operate businesses that offer various mental health therapy services, including psychotherapy, psychotherapeutic yoga, and other therapy services and related products and services utilizing a proprietary operating system and marks, including the mark LIFEOLOGIE INSTITUTE. The total investment necessary to begin operating a single franchised business ranges from \$69,650 to \$125,150, which includes \$19,900 that must be paid to franchisor or its affiliates before opening.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
