The franchise offered is for an upscale wellness and age management center featuring vitamin injections, oral vitamins, neurofeedback services, metabolic boosting, hormone management, weight loss, stress management, brain balance services and smoking cessation programs, together with related services, products and merchandise.

The total investment necessary to begin operation of LifeXist Center ranges from \$236,600 to \$355,850. This includes \$50,000 that must be paid to the franchisor or its affiliates. If you are signing a Multi-Unit Development Agreement, you must pay us a MUD Fee equal to \$50,000 for the first Center, \$35,000 for the second Center and \$25,000 for each additional Center contracted for under the Multi-Unit Development Agreement. The minimum number of Centers you must develop under a Multi-Unit Development Agreement is 5, which results in a minimum MUD Fee equal to \$160,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement, with, or make any payment to, the franchisor or an affiliate in connection with the proposed sale. **Note however, that no governmental agency has verified the information contained in this document.**
